

**RECTOR'S RESOLUTION OF 21 JULY 2023 PUBLISHING THE CALL FOR POSTDOCTORAL CONTRACTS AT THE UNIVERSITY OF VALLADOLID 2023**

The essential aim of the University is the transmission and generation of knowledge, which is why the promotion of scientific and technical research is one of the basic pillars in its strategic lines of action. In this sense, in order to fulfil its aims, the University of Valladolid has been developing its teaching and research activity, being called by reason of its mission and objectives to establish the means to enable the exchange and transmission of knowledge, generation, transfer to the industrial fabric and social dissemination, for the benefit of culture and social welfare.

The purpose of this call is the temporary employment of PhDs with a solid scientific background to strengthen and/or promote lines of research and collaborations that can be framed in future calls for national and international projects (especially within Horizon Europe), or in projects of technology transfer and social dissemination.

These contracts have a dual purpose: on the one hand, to attract and retain talent. On the other hand, to strengthen the scientific/technical potential of the University of Valladolid's own Research Groups, Centres and Institutes by carrying out projects that reinforce their lines of research and transfer.

For the above reasons and following the agreement of the Research Commission of the University of Valladolid, within the framework of the lines of action for teaching and research staff of the University of Valladolid for 2023 approved by the Governing Council on 24/03/2023, and negotiation with the representatives of the PDI of the University of Valladolid, I have decided to publish the following call for applications.

**BASIS****First. Object**

1. The purpose of this resolution is to call, on a competitive basis and applying the principles of merit, capacity, publicity and objectivity, 11 contracts for the incorporation of PhDs into recognised research units, to improve their productivity and facilitate the rejuvenation of the research staff, making it possible to achieve accreditation as lecturers with permanent contracts. In this call, research units are understood to be research groups with recognised research capacity (GIR) and University Research Institutes.

One of the positions will be linked to the researcher of the Beatriz Galindo Senior programme (**BG-S modality**) who has not been able to select a candidate in the last call (Annex A). Of the remaining 10 places (**ordinary modality**), at least one contract will be assigned for each of the five main branches of knowledge (Arts and Humanities; Sciences; Health Sciences; Social and Legal Sciences; and Engineering and Architecture), provided that there are candidates in each branch who exceed the minimum score established in base nine.2. **One** of the total number of **places** is reserved for people with a disability equal to or greater than 33 per cent; if this place is not filled, it will be incorporated into the general quota. The distribution of places will be carried out in the manner described in base ten.

2. The work will necessarily be carried out in a centre and a LOSU department or institute of the University of Valladolid (hereinafter, UVa), linked to the development of one or more research projects, as provided for in this call. The contracted person will be linked, for all purposes, to the teaching unit of his/her researcher tutor (or co tutor, if applicable).



3. The projects, to the implementation of which this call contributes, shall comply with the Code of Good Practice in Research, approved by Agreement of the Governing Council on 31 January 2013.

4. The European Commission Recommendation (2005/251/EC) of 11/03/2005 (OJEU L75 of 22/03/2005), on the "European Charter for Researchers" and "Code of Conduct for the Recruitment of Researchers" will be applied to the grants called in this resolution.

### *Second. Requirements for applicants*

1.- Without prejudice to the general requirements established in *R.D. Legislative 5/2015, of 30 October, which approves the revised text of the Law of the Basic Statute of the Public Employee (EBEP)* on access to public employment, the following requirements are established that must be fulfilled by the date of expiry of the period established for the submission of applications to this call for applications:

- a. Hold a doctoral degree. The date of obtaining the doctorate degree must be after 31 December 2017. The date of obtaining the doctoral degree will be understood to be the date of the defence and approval of the doctoral thesis of your first doctorate. When any of the following situations apply, an extension of the deadline for obtaining the doctorate degree will be applied:
  - i. Care of a child, whether by nature or by adoption, or in cases of foster care for the purpose of adoption or permanent foster care, when the date of birth or, where applicable, of the judicial or administrative decision has taken place between 1 January 2018 and the current date. An extension of 1 year shall be applied for each child.
  - ii. Serious illness or accident of the applicant, with medical leave of 3 months or more, consecutive and uninterrupted, which occurred between 1 January 2018 and the current date. An extension equal to the period of justified sick leave will be applied, rounded up to full months.
  - iii. Care for people in a situation of dependency, in accordance with the provisions of Law 39/2006, of 14 December, on the promotion of personal autonomy and care for people in a situation of dependency, for a minimum period of 3 months, which has taken place between 1 January 2018 and the current date. An extension equal to the justified period will be applied, rounded up to full months.These periods shall be indicated and duly substantiated at the time of submission of the application.
- b. To have spent a period of 12 months or more in one or more R&D centres other than the centre where they carried out their doctoral training (different CIF). At least 9 months of this period must have been spent as postdoctoral research staff or equivalent and one of the postdoctoral stays must have lasted 3 months or more. In the case of accreditation of postdoctoral stays in companies, only the contract with the category of doctoral researcher and in the R&D&I area of the company will be accepted. For the purposes of this section, the centre where the doctoral training has been carried out will be considered as the centre where the majority of the research activities leading to the acquisition of the competences and skills necessary to obtain the doctoral degree have been carried out and where the doctoral thesis has been read. The accreditation of the stays will be carried out with a certificate issued by the institution where the stay was carried out.



2.- A member of the teaching and research staff of the UVa who is an ordinary member of a GIR or Institute, or who is a research staff member of the IBGM-CSIC, who must be in possession of a six-year active research period (either research or transfer), who will act as a researcher tutor, must accept the application. The person responsible for the proposing unit (Coordinator of the GIR or Director of the Institute) must approve the application, according to model Annex 1. In the case of the BG-S modality, the tutor will be the Beatriz Galindo contract holder offering the position, without the need for approval.

3.- Candidates who have submitted their application for the BG-S modality may submit another application for the ordinary modality, but they must have a tutor who fulfils the requirements of the previous point and is different from the person hired by the Beatriz Galindo Programme.

### *Three. Financing of contracts*

1.- These contracts shall be financed from the budget application 180113-463A.2.03-691 of the UVa Budget for 2023 and from the corresponding budget application of the UVa Budgets for the following years.

2.- The aid is subject to the suspensive condition of the existence of adequate *and* sufficient credit at the time of the award decision.

### *Four. Characteristics of the contract*

1. The UVa will formalise an employment contract with the selected candidates for a duration of three years, preferably in accordance with Article 22 of Law 17/2022, of 5 September, which amends Law 14/2011, of 1 June, on Science, Technology and Innovation.

2. Contracts may be extended, once only, for one of the following reasons:

- a. In the event that the persons recruited achieve R3 accreditation before the end of the contract, in which case the contract will be extended for a further two years.
- b. In the event that the contracted person obtains, as principal investigator, a national or European competitive project of at least three years' duration, in which case the contract will be extended for the time remaining until the initial end of the project.

In the event that, due to the extension, the contracted person completes the maximum time allowed by art. 22 of Law 17/2022, of 5 September, which modifies Law 14/2011 for the access contract for doctoral research personnel, another contract will be formalised in accordance with the regulations applicable at that time, until the end of the new extension period, under the conditions established in this call for applications.

3. Obtaining R3 accreditation (or having I3 accreditation) will entail the allocation of a post (PTUN or PPL, as the case may be) at the latest within the last six months prior to the end of the postdoctoral contract, depending on the availabilities established in the annual action lines for teaching and research staff and on budgetary availabilities.

4. The remuneration that each researcher will receive, and which will be stated in the contract, will be €33,300 gross per year (equivalent to that of a contract of the first phase of the Ramón y Cajal 2022 programme) during the first three years of the contract and until obtaining, where appropriate, the R3 certificate if this is obtained after the end of the third year.

During the second phase, once the R3 certificate has been obtained and the third year of the contract has expired, the remuneration will be €39,900 gross per year.



5. The beneficiaries of the contracts may, at their own request and subject to prior agreement with the teaching unit to which they are assigned, provide complementary collaborations in teaching tasks, up to a maximum of 100 hours per year, in accordance with the Instruction of 24/11/2021 establishing the Procedure for the assignment of teaching collaborations to pre-doctoral and post-doctoral researchers of the University of Valladolid, subject to the current regulations on incompatibilities of staff in the service of the Public Administrations.

6. The interruption of the contract shall not entail the extension of its duration, except when it is caused by a situation of temporary incapacity (for a period of at least three consecutive months) or by any of the other situations contemplated in art. 22 of Law 17/2022, of 5 September, which amends Law 14/2011 on Science, Technology and Innovation.

7. The contracts financed under this call for proposals are subject to the incompatibility regime established in Law 53/1984, of 26 December 1984, on incompatibilities of staff in the service of public administrations and its implementing provisions.

### *Fifth. Requirements for the researcher tutor*

#### **Ordinary mode**

1. The researcher tutor, who will be directly responsible for the tutoring and guidance of the professional development of the candidate, will be an ordinary member of a GIR or Institute of the UVa and will be in possession of a living sexennium (research or transfer).

2. In order to participate in this call, the proposing units (RICs or Institutes) must have at least three living sexennials (research or transfer) among their ordinary members.

3. It shall be a requirement for participation that any of the ordinary members of the GIR or the Institute is the PI of a live research project of any competitive research or knowledge transfer call with funding from national or European agencies and administrations. Only those projects of the aforementioned calls in which the beneficiary is the UVa, the General Foundation or the Science Park Foundation of the UVa or a public research organization that maintains a stable and valid collaboration agreement with the UVa through a joint centre (CSIC through the IBGM) will be considered. This requirement must be met by the deadline for submission of applications.

4. Only one application per research unit (GIR or Institute) will be allowed (applications submitted by a GIR whose coordinator is also a member of an Institute will be counted separately from that of that Institute). Failure to comply with this section will result in the exclusion of all applications submitted linked to the same unit (GIR or Institute). This exclusion may only be remedied if, within the period established for this purpose, the coordinator of the GIR or the Director of the Institute that has given the agreement opts for one of the applications. In the absence of such an option, all applications from that research unit shall be excluded without further action.

5. Researcher tutors cannot be those who at the closing date of this call are currently tutors of a person with a postdoctoral contract of the calls in execution of the UVa's own programme. This condition cannot be remedied.

6. In the case that the researcher tutor is a research staff member of the IBGM-CSIC, an ordinary member of the PDI of the UVa must also be appointed, who will act as a co-supervisor of the contracted person. The position will be linked for all purposes to the area of knowledge of the co-tutor and the co-tutor will be administratively responsible for the person hired.

7. All the requirements of this base will be verified ex officio by the UVa, without the applicants

having to provide any documentation.

8. In order to be a tutor in this call, the publications and other results derived from the research activity must be affiliated to the University of Valladolid. This will be checked automatically through the ORCID code of the tutor, being considered that the requirement is only fulfilled if at least 90% of the publications collected in the last 5 years, or since the beginning of its link with UVA or IBGM-CSIC if later, are affiliated to the UVA.

### Mode BG-S

9. In the **BG-S modality**, the researcher of the Beatriz Galindo Senior programme of the UVA (listed in Annex A) will propose the lines of research. Any person who meets the requirements may apply, but may only have this researcher as a tutor. Only the candidate with the highest score, who meets the minimum grade requirement, will be selected. The researcher of the BG-S programme will not be able to participate as a tutor in the ordinary modality.

### *Sixth. Call for applications and deadline for submission of applications*

1. The call for applications will be published on the UVA Electronic Notice Board: <https://sede.uva.es> (Official Notice Board / Research), on the [UVAINVESTIGA](https://www.uva.es/uvainvestiga) website, on EURAXESS, and in the Official Gazette of Castilla y León.

2. The period for submission of applications shall begin at **9.00 a.m. on 17 August 2023 and end at 2.00 p.m. on 20 September 2023 (local time in both cases)**.

### *Seventh. Form of submission of applications*

1. In attention to the technical capacity of the possible persons interested in participating in this call, the application must be formalised in the model available at the UVA E-Office, at the address <https://sede.uva.es> accompanying the documentation required in the eighth base of this call, available at the same address in the case of standard models. You must access the **citizen folder**, and after identifying yourself, you must choose the option "initiate procedure", or "continue procedure" if it has been initiated previously. From the catalogue of active procedures, choose the **Call for postdoctoral junior contracts of the University of Valladolid**. Once the application has been completed, it must be accompanied by the documents indicated in the eighth base of this call, whose standard models will also be available on the website of the UVA research support service: <https://investiga.uva.es/gestion-y-resultados/convocatorias-de-investigacion/contratos/>

2. Preferably, an electronic signature certificate is required to access the procedure. After authenticating with an electronic signature certificate you will have access to the procedure. It is important to read the "**help instructions**", where you can obtain information on the procedure for attaching documents and how to continue or consult an application that has already been started. Please note that the maximum number of documents that can be attached to an application is 10 and that they cannot take up more than 10 MB in total.

Applicants who do not have an electronic signature may access this procedure by obtaining a user through the Unified Register of Applicants of the University of Valladolid (RUS) at the following address: ACCESS RUS-UVA. If the applicant is already a student, or a member of the PAS/PDI of the UVA, they should not use RUS. Nor should it be used if you have a digital certificate, electronic ID or

user of the Cl@ve system. Applications submitted in this way will produce the same legal effects as those formulated in accordance with article 16.5 of Law 39/2015, of 1 October, of the Common Administrative Procedure of Public Administrations.

4. Applicants must check at the electronic headquarters (<https://sede.uva.es>), prior to filling in the documentation, that the computer equipment to be used to electronically record the documentation meets the minimum requirements.

5. The e-mail address [sopORTE-sede@uva.es](mailto:sopORTE-sede@uva.es) will provide assistance in resolving technical incidents that may arise for interested persons as a support for possible queries relating to the recording of data.

6. A copy of the registered document may be obtained in the same Virtual Office, in the "file consultation" section.

7.- Each applicant may only submit one application. In the event that there are two applications from the same person, the applicant will be considered to have chosen the one submitted last according to the date and time of registration at the University, and any application submitted earlier will be considered null and void.

8.- When an unforeseen technical incident or a necessary planned technical maintenance action has prevented the ordinary operation of the UVa's electronic office or the system or application corresponding to the General Electronic Registry, an extension of the unexpired deadlines may be agreed. If the technical incident occurs within the last twenty-four hours of the established deadline, the deadline will be automatically extended by twenty-four working hours from the end of this period. If, once this period has been extended, it is foreseen that the technical incident may persist beyond those twenty-four working hours, the competent body for each procedure may agree, expressly and with reasons, to extend the period under the terms of article 32 of Law 39/2015, of 1 October. In all cases, both the technical incident or prior notice of planned unavailability and the specific extension of the deadline, with reference to the procedures affected by such extension, must be published in the electronic headquarters.

### *Eighth. Content of applications*

1. **Applications** must be accompanied by the following documents:
  - a. Document accrediting the **acceptance of the candidate** by a UVa researcher tutor (and co-tutor, if applicable), with the agreement of the coordinator of the GIR or director of the Institute, in the standard form **in Annex 1**. It will not be necessary to accredit the requirements of said researcher/tutor (and co-tutor, if applicable), which will be checked ex officio. In the case of the BG-S modality, the tutor will be the Beatriz Galindo Senior researcher offering the position.
  - b. **List of contributions**. The standard form available as **Annex 2** must be completed. It shall indicate the contributions considered most relevant for the evaluation, up to a maximum of five contributions, ordinary or extraordinary. "Contribution" shall be understood as any of those established in the Resolution of 21 November 2022, of the National Commission for the Evaluation of Research Activity, which publishes the specific criteria approved for each of the fields of evaluation (BOE 21 December 2022). In case of providing more than 5, only the first 5 will be evaluated.

Contributions that are not accessible via the internet (in open format) must be attached as a pdf file, generating a single file together with Annex 2. The file "**aportaciones\_primer apellido**" must not exceed 5 Mb, in accordance with the rules established by the evaluation agencies.



- c. **Curriculum vitae**, specifying the merits that can be assessed in sections **3.b**, **3.c** and **3.d** of the ninth base of this call for applications. The file "**CV\_first surname**" may not exceed 5 Mb, in accordance with the rules established by the evaluation agencies.
- d. Copy of a valid passport (only for foreign citizens not resident in Spanish territory). In the case of Spanish citizens or foreign citizens residing in Spanish territory, participation in this action will entail consent for the examining body to consult and verify the identity data included in the application, by means of the Identity Data Verification System, in accordance with the sole article.3 of Royal Decree 522/2006, of 28 April.
- e. Copy of the doctoral degree or of the academic certification, with an express indication of the date on which the doctoral degree was obtained.
- f. **Certificate accrediting the periods of the candidate's stay**, signed by the person responsible at the institution where the stay was carried out. This certificate/document must necessarily state the status of the person signing it and the research activity carried out. Documentation that does not meet these requirements will not be accepted, which will lead to the exclusion of the applicant, without prejudice to the provisions of base ten.3.
- g. Report on the research work to be carried out by the candidate, setting out a research activity project to be carried out (free format not exceeding 5 pages in DINA4 format).
- h. If applicable, accreditation of disability status or of the circumstances accrediting the extension of the thesis reading period.

2. For the purposes of the evaluation process, only the information contained in the CV, the list of contributions, the working memory and the certificate(s) of stay(s) at the closing date for the submission of applications will be taken into account. It will not be possible to update the information contained in these documents at a later date. In the event that rectification, correction or clarification of such documents is requested, the information provided must refer, at the latest, to the closing date for the submission of applications, and documents that include information that was not contained in the original document will not be accepted. Failure to submit the curriculum vitae, the list of contributions or the work report may not be remedied. The absence or lack of content of any of these documents will result in the rejection of the application.

3. The submission of the application implies acceptance of the terms and conditions of the call for applications and consent to be notified at the e-mail address indicated therein.

4. The list of contributions, the curriculum vitae and the certificate of the research stays will be the documents to be sent to a duly accredited external evaluation agency for assessment. The report will be sent for consideration as a clarifying element to assist in the evaluation. Documents weighing more than 5 Mb will not be accepted, in accordance with the rules established by the evaluation agencies.

### *Ninth. Evaluation Criteria*

1. The evaluation will be carried out in accordance with ANNEX II of the EVALUATION MANUAL: RESEARCH RESULTS AND MERITS FOR POSTDOCTORAL CONTRACTING (2018 edition) accessible at <http://www.acsucyl.es/web/es/programas-evaluacion/meritos-para-contratacion-personal.html>.

2. In order to be eligible for contracts under this call, the evaluation obtained must be a **MINIMUM of 75 points**.

3. Applications will be assessed out of **100 points**, in accordance with the following merit assessment criteria:

- a) **"Selected scientific contributions". Up to 50 points.**



The five contributions presented as "List of Contributions" in Annex 2 will be assessed, in accordance with the criteria established in the Resolution of 21 November 2022, of the National Commission for the Evaluation of Research Activity, which publishes the specific criteria approved for each of the fields of evaluation (BOE 21 December 2022).

**b) "Other curricular merits". Up to 30 points.**

All those merits reflected in the curriculum vitae in accordance with art. 8.1.c) which have not been highlighted as a contribution and which refer to:

1. **"Other publications"**. Up to 15 points.
2. **"Research projects"**. Up to 15 points.
3. **"Knowledge transfer"**. Up to 15 points.

(c) **'Stays in research centres'**. Only the length of stay that exceeds the time required to participate in the call will be valued. **Up to 15 points.**

(d) **"Prizes and awards"**. **Up to 5 points.**

4. These criteria aim to determine the way in which the assessment will be carried out, although their application is not automatic, as they must be modulated according to the circumstances of each discipline and within the framework of the provisions of article 16.2 of Law 14/2011, of 1 June.

5. In the case of the BG-S modality, sections a)-d) will be weighted 70% of the final total mark. The remaining 30% will correspond to the suitability of the candidate's profile in accordance with the profile requested by the BG-S researcher, as specified in Annex A. Each BG-S researcher will assess the CV and contributions, as well as the suitability of the candidate's profile, issuing a scientific-technical report on each of the applicants for their respective contract, which will be supervised by the Research Committee.

### ***Tenth. Instruction and resolution of the procedure***

1. The competent body for the instruction and organisation of the procedure shall be the UVa Research Support Service.

2. At the end of the deadline for submission of applications, the Vice-Rector for Research, by delegation of the Rector, shall publish on the UVa electronic notice board the provisional lists of persons admitted and excluded, with an indication in the latter case of the cause of exclusion. In the case of the BG-S modality, the publication of the provisional lists of those admitted and excluded may be carried out independently of the ordinary modality.

3. Both the candidates excluded and those omitted, the latter because they do not appear on either the lists of those admitted or those excluded, shall have a period of 10 working days, counted from the day following the day after the aforementioned publication on the electronic notice board, to rectify the defects that have led to their exclusion or omission.

4. The publication of these lists on the aforementioned notice board shall serve as notification to the interested parties for all purposes. Applicants who, within the aforementioned period, do not rectify the exclusion or do not argue against the omission, justifying their right to be included, shall be definitively excluded from the selection process.

5. Once the period for rectification has elapsed, the Vice-Rector with responsibility for Research, by delegation of the Rector, shall publish the resolution approving the definitive list of persons admitted and excluded on the same electronic bulletin board. A contentious-administrative appeal may be lodged against this resolution, as a qualified procedural act, within a period of two





months, before the Contentious-Administrative Court of Valladolid, or, alternatively, an appeal for reconsideration, within a period of one month, before the Rector's Office itself. Both periods will be calculated from the day following the publication of the resolution.

6. The Research Commission of the Governing Council of the UVa is responsible for the study of applications, for which it may request a scientific-technical evaluation report of each application to a duly accredited external evaluation agency, or other types of reports, in the terms established in the ninth base. In the case of the BG-S modality, the Beatriz Galindo senior researchers (listed in Annex A) must issue a scientific-technical evaluation report on each application.

7. The proposed resolution formulated by the Research Committee will include the scores assigned to each applicant in each of the sections, and will be published on the UVa's electronic notice board. In the BG-S modality, once the scientific-technical evaluation reports of the applications submitted have been received, a partial resolution may be made independently of the ordinary modality.

**8. Allocation of places.** In the first place, applications that do not reach the minimum score foreseen in the ninth base, section 2 will be rejected. The available places will be allocated among the remaining candidates according to the following procedure:

- a. First phase: in the BG-S modality, for each Beatriz Galindo Senior researcher (as set out in Annex A), the candidate with the highest score will be proposed for recruitment, as established in base nine.
- b. Second phase: The candidate with the best score in each of the five branches of knowledge will be proposed for recruitment. If none of the candidates proposed belong to the disability category, the candidate with the highest score among those competing in the disability category who have passed the minimum mark required will be selected at this point. Once this distribution has been made, if in a branch of knowledge there is no candidate who exceeds the minimum score established in base nine.2 of this call, the corresponding vacancy will be added to those of the third phase. In the event that any of them resigns during the award procedure, they will be replaced by the next candidate in that area with the best mark, if there is one.

In this phase priority will be given, provided that the minimum threshold indicated in section nine.2 is exceeded, to applications corresponding to areas of knowledge in which no person with a postdoctoral researcher contract with a commitment to stabilisation of the postdoctoral contract programmes of the University of Valladolid has been incorporated since 1 January 2019. In the event that this does not cover all the contracts offered, contracts may also be assigned to these areas of knowledge, always following the specified procedure. The area of knowledge of the candidate's tutor will be taken as the reference area of knowledge.

- c. Third phase: The remaining candidates evaluated, who have passed the minimum score established in base nine.2 of this call for applications, will be ranked in descending order of score, and the candidates with the highest scores will be proposed for recruitment until the remaining vacancies offered are filled.
- d. In the event of a tie, the tie-breaker shall be decided according to the following criteria:
  - i. In first place: best score in the contributions section.
  - ii. Secondly, if necessary: better score in the section on other curricular merits according to the order of the evaluation items.

- iii. In third place, the candidate of the least represented gender among the candidates already selected.
- iv. In the event of a tie, lots shall be drawn by lot.

9. Allegations may be submitted to the Rector within 10 working days of its publication on the UVa's electronic notice board. These allegations will be assessed by the Research Commission, which may request the relevant reports in this regard.

10. The rector's resolution ending the procedure shall be published on the UVa's electronic notice board.

11. The rector's resolution that ends the procedure may list the candidates on the waiting list who, following the order of the points obtained, may replace those granted in the event of resignations or other circumstances. The waiting list will be made up of the candidates admitted and not proposed for recruitment resulting from the first, second or third phases described above, who have passed the assessment established in base nine.2. The waiting list will be valid for a maximum of six months from its publication. Vacancies occurring after the six-month period may be included in the next call for applications, subject to budgetary availability.

12. Beneficiaries must accept the grant and notify the date of incorporation within 10 days of the publication of the final resolution, by submitting the completed form ANNEX 4 through the electronic register of the UVa. Failure to accept within the deadline will be understood as resignation from the contract. The incorporation to the post must take place within 6 months from the day following the publication of the Resolution of concession. If the incorporation does not take place within the indicated deadlines, it will be understood as resignation from the contract.

### *Eleventh. Notifications*

1. Pursuant to the provisions of Article 45.1.b) of Law 39/2015, of 1 October, on the common administrative procedure for public administrations, notifications will be made by publication on the UVa's electronic notice board, with all the effects of notification.

2. When completing the application form, interested parties may indicate an e-mail address where they may be notified of new actions or incidents in the procedure. In such a case, the investigating body may send the interested party a message, via e-mail, informing him/her that this new action has taken place and that he/she may obtain reliable and detailed information about it by accessing <https://sede.uva.es>.

### *Twelfth. Follow-up*

1. The persons contracted shall draw up a scientific-technical **monitoring report** to be submitted during the first month of the third year, using the model and procedure that will be indicated in due course. This report shall include a description of what has been carried out and of the fulfilment of the objectives set out in the candidate's research report to date, and shall be evaluated by the Research Committee, for which it may be advised by experts. If the evaluation is not positive, the contract may be terminated in accordance with the applicable regulations.

2. The contracted persons shall draw up a **final scientific-technical report**, using the model and procedure that will be indicated in due course, and submit it within one month of the day following the end of the contract. This report shall include a description of what has been carried out and the fulfilment of the objectives during the contract.

3. The evaluation that allows access to the second phase of the contract will be carried out by

participating in the R3 call - established researcher - of the State Research Agency, at the time that the postdoctoral contract holder considers appropriate and with the requirements established therein. If the evaluation is positive, the economic effects of the same, in accordance with the fourth base.4, will begin in the fourth year or on the date on which it is obtained if this is later.

4. The **modification** of the initial conditions of the contract shall be authorised by the Vice-Rector with responsibility for research, who may request such reports as he/she deems appropriate.

5. Contracted staff shall be obliged to **give at least 10 days' notice** of resignations, interruptions and other incidents in the contracts financed under this call, as well as of any cause of incompatibility.

### *Thirteenth. Resolution period*

1. The time elapsed between the end of the application period and the resolution of this call for applications may not exceed six months, except for the concurrence of the legal cases of suspension or extension of the period due to contestation and other justifiable causes appreciated by the Rector.

2. That period shall be suspended for the time between the request for a report to an evaluation agency and its receipt, which shall be recorded in the file.

### *Fourteenth. Legal regime*

1. The call will be governed by the following rules:

- Ley Orgánica 2/2023, de 22 de marzo, del Sistema Universitario (B.O.E. de 23 de marzo de 2023).
- Law 17/2022, of 5 September, which amends Law 14/2011, of 1 June, on science, technology and innovation (BOE 6 September 2022).
- R.D. Legislative 5/2015, of 30 October, approving the revised text of the law on the basic statute of public employees.
- Organic Law 4/2000 of 11 January 2000 on the rights and freedoms of foreigners in Spain and their social situation (BOE of 12 January 2000).
- Royal Legislative Decree 2/2015 of 23 October 2015, approving the revised text of the Workers' Statute Law (BOE of 24 October 2015).



- Decree 67/2013, of 17 October, which develops the regulation of the regime of contracted teaching and research staff in the public universities of Castilla y León.

2. The Regulations for the contracting of research personnel and collaborating personnel in research tasks, financed on a finalist basis from projects, contracts, agreements or research agreements, approved by the Agreement of the Governing Council of the UVa of 31 January 2013, shall be applicable on a supplementary basis.

### *Fifteenth. Personal data protection measures*

1.- The personal data resulting from this call for applications will be treated confidentially and will be incorporated into processing files owned by the University of Valladolid, for the purpose of resolving the call for applications. They will be kept for the time necessary to fulfil this purpose and the data of the contracts awarded will be kept for the appropriate certification and statistical purposes.

2.- The information document on the protection of personal data is included as Annex B to this call for applications.

### *Sixteenth. Gender issue*

In coherence with the value of gender equality assumed by the University, all the denominations that in this resolution are made in the masculine gender, when they have not been substituted by generic terms, will be understood to be made indistinctly in the feminine gender.

### *Seventeenth. Resources*

1. A contentious-administrative appeal may be lodged against this decision, which exhausts administrative channels, within two months of the day following its publication, before the competent contentious-administrative court in Valladolid (Articles 8.2 and 13 of Law 29/1998, of 13 July, on contentious-administrative jurisdiction).

2. Alternatively, an appeal for reversal may be lodged with the Rectorate of the University of Valladolid, within a period of one month from the day following its publication. In this case, the aforementioned contentious-administrative appeal may not be lodged until it has been expressly resolved or until the appeal for reconsideration has been presumptively rejected. Likewise, any administrative acts deriving from it and from the actions of the selection board may be challenged by the interested parties in the cases and in the forms established in Law 39/2015, of 1 October, on the common administrative procedure of public administrations.

**Scientific lines of work:** Development of techniques for the detection of chirality by molecular spin spectroscopy.

**Project topic(s):** The study of chiral molecules in the gas phase will be addressed through the implementation and development of novel methods based on both chiral tagging and three-wave mixing experiments. These techniques allow a precise determination of both the enantiomeric excess and the absolute configuration of a molecule that is responsible for a specific biological activity. In addition, the high resolution and sensitivity of rotational spectroscopy will be used for the precise structural determination of molecules and molecular aggregates of interest.

**Profile expected of the candidate:** The successful candidate is expected to have a PhD in Physics or Chemistry with knowledge of spectroscopy and interest in the development of new experimental techniques. We are looking for a motivated person interested in developing a research career.
